BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to budget and commit an estimated \$2 million in increased sales and transient occupancy taxes which are anticipated to be derived from the 1996 Republican National Convention to assist in defraying any costs incurred by the City in hosting the Convention.

BE IT FURTHER RESOLVED, that the City Auditor and City Manager be and they are hereby directed and authorized to:

- 1. Cause the establishment of trust funds,
- accept contributions,
- 3. budget funds received, and
- 4. subject to the annual appropriation ordinances of the City Council, expend or transfer funds to the appropriate departments and agencies for purposes related to hosting the 1996 Republican National Convention, provided that, the City Auditor certifies that the funds necessary for expenditure are, or will be on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 from the Major Event Fund (Fund 102241) for immediate expenses related to meetings and negotiations with the Republican National Committee concerning the 1996 Convention be and it is hereby authorized.
