WHEREAS, the people of the State of California have enacted the California Oil Recycling Enhancement Act that provides funds to cities and counties for establishing and maintaining local used oil collection programs that encourage recycling or appropriate disposal of used oil; and

WHEREAS, the California Integrated Waste Management Board has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by cities and counties under the program; and

WHEREAS, the applicant will enter into an agreement with the State of California for development of the project; NOW, THEREFORE.

BE IT RESOLVED, by the Council of The City of San Diego, that the submittal of an application of the Third Cycle Used Oil Recycling Block Grant and the subsequent acceptance of the grant award of \$372,072 or any alternate or augmented award from California Integrated Waste Management Board for reimbursement of expenditures related to the collection and recycling of used oil and oil filters during Fiscal Year 1996 is hereby approved.

BE IT FURTHER RESOLVED, that the Deputy Environmental Services Director, Programs Division, or their designees, is hereby authorized and empowered to execute in the name of the City of San Diego, all necessary applications, contracts, payment

requests, agreements and amendments hereto for the purposes of securing grant funds and to implement and carry out the purposes specified in the grant application.

BE IT FURTHER RESOLVED, that contingent upon approval of the Fiscal Year 1996 budget, expand the grant award by continuing the existing activities and agreements outlined in the grant application for Fiscal Year 1996.

BE IT FURTHER RESOLVED, that contingent upon approval of the Fiscal Year 1996 budget, continue the grant funded position to administer the grant activities in Fiscal Year 1996.

BE IT FURTHER RESOLVED, that contingent upon approval of the Fiscal Year 1996 budget, that the expenditure of \$334,279 from Fund 41200, Dept. 751, Account No. 4222, Job Order 7520, reimbursable nonpersonnel costs or alternate award or augmentation to implement this grant in Fiscal Year 1996 is hereby authorized.
