Triple Combination approved, and the hereby low bid Apparatus are specifications, of SAULSBURY FIRE EQUIPMENT CORP., of Preble, New York, is hereby accepted and the City Manager is hereby authorized to execute a contract with the low acceptable bidder for the purchase of TWO (2) EACH SERVICE AERIAL LADDER TRUCKS (Section I), at a cost of \$413,985.20 each, AND FIVE (5) EACH 1500 G.P.M. TRIPLE COMBINATION APPARATUS, at a cost of \$279,401.68 each, for a total combined cost of \$2,224,978.80 plus applicable sales tax, with cash payment discount terms of 1% 21 days, with options to purchase additional trucks and apparatus and pump modules, with option year price increases not to exceed the prices in effect for the previous contract period by more than the C.P.I. plus 6 and 7%, repectively.

BE IT FURTHER RESOLVED that the expenditure, not to exceed \$2,380,727.32 from Fund No. 100, Department No. 120, Organization No. N/A, Object Account No. 6016, and Job Order No. 5700, is hereby authorized solely and exclusively for providing funds for said contract, and the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
