

RESOLUTION NUMBER R- 285245

ADOPTED ON JAN 23 1995

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a phase funded contract with Kercheval Engineers, for design services in connection with the Dairy Mart Road and Bridge Improvements, under the terms and conditions set forth in the Design Agreement on file in the office of the City Clerk as Document No. RR- 285245, together with any reasonably necessary modifications or amendments thereto which do not increase the project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer an amount not to exceed \$445,026 within Sewer Fund No. 41509, from CIP 42-910.6, South Bay Water Reclamation Plant, to CIP 45-923.0, Dairy Mart Road and Bridge Improvements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,746,850 from Sewer Fund No. 41509, CIP 45-923.0, Dairy Mart Road and Bridge Improvements, is hereby authorized, solely and exclusively to provide funds for the design project and additional services, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for this expenditure under established contract funding phases are, or will be, on deposit in the City treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
