BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SKI BEACH COMFORT STATION..

BE IT FURTHER RESOLVED, that the expenditure, \$222,250 from CIP No. 22-088.0, MISSION BAY RESTROOMS, Sludge Mitigation Fund No. 10507, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
