BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Ninyo & Moore, for as-needed annual geotechnical consultant services for the Water Utilities Department, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 285307, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000, consisting of \$100,000 from CIP 73-312.0, Annual Allocation - As-Needed Consultant Services/Water, and \$100,000 from CIP No. 46-174.0, Annual Allocation - As-Needed Consultant Services/Sewer, is hereby authorized, solely and exclusively to provide funds for the above project.
