BE IT RESOLVED, by the Council of The City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF HARVEY ROAD DRAIN, on file in the office of the City Clerk of San Diego, California on FEB 13 1995, and bearing official Document No. W.O. 112137, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF HARVEY ROAD DRAIN.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$18,000 from CIP 18-001.0, Annual Allocation - Cooperative Storm Drain Projects, TransNet Fund 30300, to CIP 12-067.0, Harvey Road Drain, and authorized to expend \$190,000, \$48,000 from TransNet Fund 30300, \$25,000 from State and Local Partnership Program, \$117,000 from DIF Fund 79512 from CIP 12-067.0, Harvey Road Drain, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to appropriate reserves.
