BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a fourth amendment to the agreement of March 6, 1989 with Boyle Engineering Corporation, to provide engineering services in connection with the Rose Canyon Trunk Sewer, under the terms and conditions set forth in Amendment No. 4 on file in the office of the City Clerk as Document No. RR- ~~285397~~, as well as any further amendments or modifications to the agreement which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,436 from Sewer Revenue Fund 41506, CIP No. 46-111.0, Rose Canyon Trunk Sewer, is hereby authorized, solely and exclusively to provide funds for the above amendment.


