
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to continue the Community Based Toilet Replacement Program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego County Water Authority, to implement and administer the Community Based Toilet Replacement Program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 285402.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from the Water Utilities Department Operating Fund (41500), Water Conservation Program (70622), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
