VACATION OF RATTLER WAY

WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the City Council prior to the vacation of a City street; and

WHEREAS, Section 66499.20-1/2 of the California Government Code provides that the file of the map shall constitute abandonment of all streets and easements not shown on said map; and

WHEREAS, the abutting property owners have requested the vacation of Rattler Way between Top Gun Street and Steadman Street in connection with the lot line adjustment parcel map for Lots 25 through 38 of Lusk Mira Mesa Business Park East II Unit No. 2, Map 12685, to facilitate development of their property; and

WHEREAS, the portion of the street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and WHEREAS, the public street system for which the right-of-way

was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Rattler Way between Top Gun Street and Steadman Street, in connection with the lot line adjustment parcel map for Lots 25 through 38 of Lusk Mira Mesa Business Park East II Unit No. 2, Map 12685, said vacation is more particularly shown on Exhibit "A," on file in the office of the City Clerk as Document No.RR-______, and which is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, with Exhibit "A," attested by him under seal, to be recorded in the office of the County Recorder.


