A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO RATIFYING THE ELECTION RESULTS OF
FEBRUARY 11, 1995, FOR THE NORTH PARK
REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the
"Council") by Resolution No. R-276720, adopted the Procedure for
Formation of the Project Area Committee ("PAC") for the North
Park Redevelopment Project at its October 16, 1990 meeting; and

WHEREAS, the Council by Resolution No. R-277220, approved
the PAC representatives initially elected to the PAC on
December 18, 1990; and

WHEREAS, since the initial December 18, 1990, election of
PAC members, vacancies have occurred on the PAC; and

WHEREAS, an election of the PAC was conducted on
February 11, 1995, after notice and according to the PAC bylaws
and established procedures enumerated within the documents
approved by the City Council and a representative from the City
Clerk's office attended the February 11, 1995, election to ensure
its validity; and

WHEREAS, the newly elected members of the PAC have submitted
to this City Council information establishing the qualifications
of each person relative to district, category, or organization as
appropriate; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as




