- 3. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area for a period of three (3) years after adoption of the plan.


