BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Farwest Corrosion Control Company, for as-needed corrosion engineering services, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document RR- 285526, as well as any reasonably necessary modifications or amendments thereto which do not increase this agreement's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$100,000 from Water Revenue Fund No. 41500, Water Operations Engineering Program (70830), is hereby authorized, solely and exclusively to provide funds for this agreement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax exempt securities if circumstances so warrant.
