BE IT RESOLVED, by the Council of The City of San Diego that the low bid meeting specifications, of ALFA LAVAL SEPARATION, INC., of Warminster, PA, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing EIGHT (8) DEWATERING AND FIVE (5) THICKENING CENTRIFUGES, extended service contracts for four years for this equipment and additional warehousing for the equipment for a total estimated cost of \$7,650,000; and an additive alternative high performance package at a cost of \$500,000, terms net 30 days; plus applicable sales tax of \$551,810, and a 5% contingency set aside in the amount of \$407,500.

BE IT FURTHER RESOLVED that the phase funded expenditure, of \$9,109,310, from Sewer Fund No. 41509, CIP No. 42-911.4, Northern Sludge Processing Facility, Phase II, is hereby authorized solely and exclusively for providing funds for said contract, provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditure are, or will be, on deposit in the City Treasury; and the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED that the City Manager is authorized to establish contract funding phases with ALFA LAVAL SEPARATION, INC., based on actual low bid submitted in the following manner, provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for expenditure under said contract are, or will be, on deposit in the City treasury.

Phase 1: \$1,672,722 from FY95 appropriations

Phase 2: \$4,706,146 contingent upon Council appropriating funds for this purpose in FY96.

Phase 3: \$1,265,221 contingent upon Council appropriating funds for this purpose in FY97.

Phase 4: \$1,465,221 contingent upon Council appropriating funds for this purpose in FY98.
