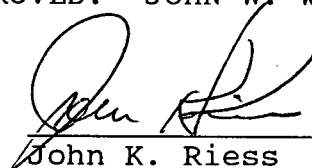
ADOPTED ON APR 10 1995

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Lintvedt McColl & Associates, to provide construction documents for Sports Arena Boulevard Improvements, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 285577.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000 from CIP 52-503.0, an amount not to exceed \$200,000 from Gas Tax Fund #302191 and \$50,000 from TransNet Fund 30300, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
