BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING AT CAMINO DE LA PLAZA AND CAMIONES WAY (LOCATION 1) AND AT FORDHAM STREET AND MIDWAY DRIVE (LOCATION 2), San Diego, California, on file in the Office of the City Clerk of San Diego, California on APR 17 1995, and bearing official document No. W.O. 112154, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING AT CAMINO DE LA PLAZA AND CAMIONES WAY (LOCATION 1) AND AT FORDHAM STREET AND MIDWAY DRIVE (LOCATION 2).

BE IT FURTHER RESOLVED, that the expenditure of \$210,000 from CIP 68-010.0 ANNUAL ALLOCATION - CONSTRUCTION TOP 10-15

PRIORITIZED TRAFFIC SIGNALS, Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess monies, if any, in CIP 68-010.0.
