BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$407,414 from Water Revenue Fund 41500, CIP No. 73-252.0, Dulzura Conduit Renovation, is hereby authorized, solely and exclusively to fund this change order and to supplement the financing of construction contingencies authorized by the Council in Resolution No. R-284078 adopted June 20, 1994.
