A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, IMPROVEMENT, OPERATION AND MAINTENANCE OF A PUBLIC STREET OR STREETS AND INCIDENTS THERETO, TOGETHER WITH RIGHT-OF-WAY FOR THE RIGHT OF INGRESS AND EGRESS OVER! UNDER, ALONG, AND ACROSS, A PORTION OF LOT 11 OF LARWIN MESA VIEW UNIT NO. 1, MAP NO. 6605 FILED IN THE OFFICE OF THE SAN DIEGO COUNTY RECORDER MARCH 23, 1970 AS FILE NO. 50937 OF OFFICIAL RECORDS, AND PORTIONS OF PARCELS 3 AND 4 OF PARCEL MAP NO. 5847 FILED IN THE OFFICE OF THE SAN DIEGO COUNTY RECORDER APRIL . 28, 1977, AS FILE NO. 77-159597 OF OFFICIAL RECORDS, AND THAT PORTION OF LOT 1 OF LARWIN SQUARE WEST UNIT NO. 1, MAP NO. 7928 FILED IN THE OFFICE OF THE SAN DIEGO COUNTY RECORDER APRIL 23, 1974 AS FILE NO. 74-103343 OF OFFICIAL RECORDS, ALL IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; AND THAT THE PUBLIC INTEREST CONVENIENCE AND NECESSITY DEMAND THE ACQUISITION OF FEE TITLE TO SAID PROPERTY FOR SAID PUBLIC STREET OR STREETS AND INCIDENTS THERETO, TOGETHER WITH THE RIGHT-OF-WAY FOR THE RIGHT OF INGRESS AND EGRESS OVER, UNDER, ALONG AND ACROSS SAID REAL PROPERTY; THAT THE PROPOSED PROJECT IS PLANNED IN A MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY, PURSUANT TO GOVERNMENT CODE SECTION 7267.2, AT THE APPRAISED FAIR MARKET VALUE HAS BEEN MADE TO THE OWNERS OF RECORD OF THE PROPERTY AND REJECTED; DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS; THAT THE TAKING AND ACQUIRING OF SAID PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS ARE DEEMED NECESSARY; THAT ACQUISITION BY EMINENT DOMAIN IS AUTHORIZED BY LAW; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF

CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY AND ACQUIRING IMMEDIATE POSSESSION THEREOF.

whereas, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; and

BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF SAN DIEGO, AS FOLLOWS:

That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the construction, improvement, operation and maintenance of a public street or streets and incidents and appurtenances thereto, together with right-of-way for ingress and egress over, under, along, and across portions of Lot 11 of Larwin Mesa View Unit No. 1, Map No. 6605 filed in the Office of the County Recorder March 23, 1970, as File No. 50937 of Official Records, and portions of Parcels 3 and 4 of Parcel Map No. 5847 filed in the Office of the San Diego County Recorder April 28, 1977, as File No. 77-159597 of Official Records, and that portion of Lot 1 of Larwin Square West Unit No. 1, Map No. 7928 filed in the Office of the San Diego County Recorder April 23, 1974 as File No. 74-103343 of Official Records, all in the City of San Diego, County of San Diego, State of California, as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of the City of San Diego, and the inhabitants of the City of San Diego, demand the acquisition and taking of fee title in said property for the construction, improvement, operation and maintenance of a public street or streets and incidents thereto, together with right-of-way for ingress and egress over, under, along and across portions of said real property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That The City of San Diego has the power of eminent domain pursuant to, <u>inter alia</u>, Section 220, of the Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, and 1255.410 of the Code of Civil Procedure; Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code; and Sections 37350.5 and 40404 of the Government Code.

Section 4. That the parcels of real property and the interests sought to be condemned are described as follows:

#### LEGAL DESCRIPTION PARCEL A

That portion of Lot 11 of Larwin Mesa View Unit No. 1, Map No. 6605, situated in the City of San Diego, County of San Diego, State of California, filed in the Office of the County Recorder of said County, March 23, 1970, as File No. 50937 of Official Records, more particularly described as follows:

Beginning at the Southeasterly corner of said Lot 11, being also the TRUE POINT OF BEGINNING, thence S88°22'00"W, 4.00 feet along the Southerly line of said Lot 11; thence N04°05'00"W, 80.94 feet to the beginning of a curve, concave Southwesterly, having a radius of 20.00 feet, thence Northwesterly along said curve through a central angle of 87°33'00", an arc length of 30.56 feet to the Northerly line of said Lot 11, thence N88°22'00"E, 4.00 feet along the Northerly line of said Lot 11 to the beginning of a curve, concave Southwesterly having a radius of 20.00 feet, thence Southwesterly along said curve through a central angle of 87°33'00", an arc length of 30.56 feet along the Northeasterly line of said Lot 11, thence S04°05'00"E, 80.94 feet along the Easterly line of said Lot 11 to the TRUE POINT OF BEGINNING.

#### LEGAL DESCRIPTION PARCEL B

That portion of Parcel 4 of Parcel Map No. 5847, situated in the City of San Diego, County of San Diego, State of California, filed in the Office of the County Recorder of said County, April 28, 1977, as File No. 77-159597 of Official Records, more particularly described as follows:

Beginning at the Southeasterly corner of Lot 11, Map No. 6605, filed in the Office of the County Recorder of said County, March 23, 1970, as File No. 50937 of Official Records, being also the TRUE POINT OF BEGINNING, thence S04°05′00″E, 204.94 feet along the EAsterly line of said Parcel 4 to the Southeast corner of said Parcel 4, thence S82°29′00″W, 5.01 feet along the Southerly line of said Parcel 4, thence N04°05′00″W, 205.45 feet to the Northerly line of said Parcel 4, thence N88°22′00″E, 5.00 feet along the Northerly line of said Parcel 4 to the TRUE POINT OF BEGINNING.

## LEGAL DESCRIPTION PARCEL "C"

That portion of Parcel 3 of Parcel Map No. 5847, situated in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of said County, April 28, 1977, as File No. 77-159597 of Official Records, more particularly described as follows:

Beginning at the Southeasterly corner of Lot 11, Map No. 6605, filed in the office of the County Recorder of said County, March 23, 1970, as File No. 50937 of Official Records, thence S04°05'00"E, 204.94 feet to the TRUE POINT OF BEGINNING, said point being the Northeasterly corner of said Parcel 3, thence S04°05'00"E, 47.01 feet along the Easterly line of said Parcel 3, to the beginning of a curve on the Easterly line of said Parcel 3, concave Easterly, having a radius of 4051.00 feet; thence Southerly along said curve through a central angle of 01°53'41", an arc length of 133.96 feet to the Southeast corner of said Parcel 3, thence S89°02'14"W, 5.02 feet along the Southerly line of said Parcel 3 to the beginning of a non-tangent curve concave Easterly, having a radius of 4056.00 feet, a radial line to said curve bears S84°01'40"W, thence Northerly along said curve through a central angle of 01°53'19", an arc length of 133.72 feet, thence N04°05'00"W, 46.68 feet to the Northerly line of said Parcel 3, thence N82°29'00"E, 5.01 feet along the Northerly line of said Parcel 3 to the TRUE POINT OF BEGINNING.

## LEGAL DESCRIPTION PARCEL "D"

That portion of Lot 1 of Larwin Square West Unit No. 1, Map No. 7928, situated in the City of San Diego, County of San Diego, State of California, filed in the office of County Recorder of said County, April 23, 1974, as File No. 74-103343 of Official Records, more particularly described as follows:

Beginning at the Southeasterly corner of Lot 11, Map No. 6605, filed in the office of the County Recorder of said County, March 23, 1970, as File No. 50937 of Official Records, thence S04°05'00"E, 251.95 feet to the beginning of a curve, concave Easterly, having a radius of 4051.00 feet, thence Southerly along said curve through a central angle of 01°53'41", an arc length of 133.96 feet to the POINT OF BEGINNING, said point being Northeasterly corner of said Lot 1, thence continuing Southerly along said curve through a central angle of 02°31'27", an arc length of 178.47 feet along the Easterly line of said Lot 1, to a reverse curve, concave Northwesterly, having a radius of 20.00 feet, thence Southwesterly along said curve through a central angle of 97°32'22", an arc length of 34.05 feet along the Southeasterly line of said Lot 1, thence S89°02'14"W, 5.04 feet along the Southerly line of said Lot 1, to a curve, concave Northwesterly, having a radius of 20.00 feet, thence Northeasterly along said curve through a central angle of 97°31'50", an arc length of 34.04 feet to a reverse curve, concave Easterly, having a radius of 4056.00 feet, thence Northerly along said curve through a central angle of 02°31'16", an arc length of 178.47 feet, thence N89°02'14"E, 5.02 feet along the Northerly line of said Lot 1 to the TRUE POINT OF BEGINNING.

Section 5. That the taking and acquiring by said City of the real property hereinabove described is deemed necessary for the construction, improvement, operation and maintenance of a public street or streets and incidents and appurtenances thereto, together with right-of-way for the right of ingress or egress over, under, along, and across said real property to serve the City of San Diego and the inhabitants thereof, for municipal purposes; that such use is a public use authorized by law (inter alia, Section 220, Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, and 1255.410 of the Code of Civil Procedure; Sections 37350.5 and 40404 of the Government Code; and Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code); that for such public use, it is necessary that The City of San Diego condemn and acquire said real property.

Section 6. That the proposed project for which this acquisition is being sought is to improve the west side of Black Mountain Road between Mira Mesa Boulevard and Gemini Avenue; that the projected traffic volumes on southbound Black Mountain Road require an exclusive right-turn lane to westbound Mira Mesa Boulevard; and that the acquisition will enable the City of San Diego to provide a safer, more efficient street system for the area community.

Section 7. That all of said real property and interests therein are to be used for the construction, improvement, operation and maintenance of a public street or streets and incidents and appurtenances thereto, and are planned and located

in a manner most compatible with the greatest public good and the least private injury.

Section 8. That an offer to acquire the property, pursuant to Government Code Section 7267.2, at the appraised fair market value has been made to the owners of record of the property to be acquired.

That the City Attorney of The City of San Diego Section 9. be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of The City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the certain real property and existing improvements as hereinbefore described in fee simple, for the use of the City of San Diego to take immediate possession thereof pursuant to California Code of Civil Procedure Section 1255.410.
