BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of said City, a phase funded contract with Parsons Engineering Science, Inc., for professional services during construction of the South Bay Ocean Outfall Extension, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document RR-285824, together with any reasonably necessary modifications or amendments thereto which do not increase the agreement's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$4,170,751 from Fund No. 41509, CIP No. 40-910.1, South Bay Outfall Extension, is hereby authorized, solely and exclusively to provide funds for the above phase funded agreement, contingency, and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City Treasury, to be expended in six phases over four fiscal years, as follows:

Phase 1 - \$263,726 from Fiscal Year 1995 appropriations.

Phase 2/3 - \$2,102,218 from Fiscal Year 1996 appropriations, provided that the City Council authorizes funding for this purpose in the Fiscal Year 1996 CIP budget.

Phase 4/5 - \$1,627,448 from Fiscal Year 1997 appropriations, provided that the City Council authorizes funding for this purpose in the Fiscal Year 1997 CIP budget.

Phase 6 - \$ 177,359 from Fiscal Year 1998 appropriations, provided that the City Council authorizes funding for this purpose in the Fiscal Year 1998 CIP budget.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
