(the "Corporation") was formed in October 1988, with the City as sole shareholder (Articles of Incorporation filed with the Secretary of State October 11, 1988) for the purposes of promoting the artistic and cultural goals and enriching the quality of life in the City of San Diego by producing artistic, musical, educational, cultural or other similar festivals or programs in and for the community of San Diego and its visitors; and

WHEREAS, the Corporation operates under Bylaws adopted by the City Council, acting as sole member of the Corporation; and

WHEREAS, the City Council desires to amend the Articles of Incorporation to change the name of the Corporation, clarify the specific purposes of the Corporation, and change the number of directors; and

WHEREAS, the City Council desires to amend the existing Bylaws as provided in existing Bylaw Section 6.04 to conform to the amended Articles referenced above; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego acting as sole member of San Diego Festivals, Inc., that the Articles of Incorporation of San Diego Festivals, Inc. be amended to:

1. Change the name of San Diego Festivals, Inc. to San Diego Civic Events Fund.

2. Amend the specific purpose of the Corporation to include the hosting, sponsorship and presentation of civic, educational, artistic, musical or cultural events, festivals or other programs that enrich the quality of life in the City of San Diego.

3. Amend the number of directors.

BE IT FURTHER RESOLVED, that Document No. RR- 285886-1, attached hereto and by this reference incorporated herein, is adopted as the Amended Articles of Incorporation, and the City Manager shall cause same to be filed with all required parties.

BE IT FURTHER RESOLVED, that Document No. RR- 285886-2, attached hereto and by this reference incorporated herein, is adopted as the Bylaws of the above referenced Corporation, superseding all other bylaws or amendments to same.

BE IT FURTHER RESOLVED, that pending the formalization and changes described above and appropriate tax law clearances, the City Auditor is directed to create a special account of the City to receive and disperse as directed by the Manager any and all contributions designated for the purposes as specified in the Articles of San Diego Civil Events Fund.

- 2. Article I of the Articles of Incorporation of this Corporation is amended in its entirety to read as follows:

3. Section (b)(1) of Article II of the Articles of Incorporation of this Corporation is amended in its entirety to read as follows:

- (a) This corporation is organized exclusively for public and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States internal revenue law, including, as limited by such purposes, operating as an organization that is organized, and at all times operated exclusively for the benefit of, to perform the functions of, to support, or to carry out the purposes of the City of San Diego.
- 5. Article VI of the Articles of Incorporation of this Corporation is amended in its entirety to read as follows:

The number of directors shall be three (3), unless fixed at a higher number, not more than nine (9), from time to time by a bylaw adopted by the member.

- 6. The foregoing amendments to the Articles of Incorporation of this Corporation have been duly approved by the Board of Directors.
- 7. The foregoing amendments to the Articles of Incorporation of this Corporation have been duly approved by the sole member of this Corporation.
