BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to accept, manage and expend grant funds from the High Intensity Drug Trafficking Area Initiative as described in the Award Document and Letter, copies of which are on file in the Office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute all aspects of program operation, including any amendments, extensions, renewals, or future funding for this program, for a period of up to five (5) years, provided funding is made available by the United States Department of Justice, and /or the High Intensity Drug Trafficking Area

Initiative, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
