A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO MAKING CERTAIN FINDINGS WITH RESPECT TO FUNDING THE CENTRE CITY EAST STREET TREE PROJECT AND AUTHORIZING THE TRANSFER OF 1994 DISTRICT 8 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO THE CENTRE CITY EAST STREET TREE PROJECT IN THE CENTRE CITY EAST REDEVELOPMENT DISTRICT OF THE EXPANSION SUB AREA OF THE CENTRE CITY REDEVELOPMENT PROJECT.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for Centre City East Redevelopment District of the Expansion Sub Area of the Centre City Redevelopment Project (the "Project"); and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency proposes to provide financial assistance for the Street Tree Program in Centre City East to plant up to 600 trees in varying species; and

WHEREAS, the Centre City Development Corporation (the "Corporation") has reviewed and recommends that the Council of The City of San Diego (the "Council") consent to and authorize the Corporation to transfer one hundred thousand dollars

(\$100,000) of 1994 District 8 Community Development Block Grant ("CDBG") funds (originally allocated to Occupational Training Services) and to provide matching funds to implement the Centre City East Street Project; and

WHEREAS, the Council has duly considered all conditions of the proposed payment for the Street Tree Program and believes that the funding of the Program by the Agency are in the best interest of the City and health, safety, morals and welfare of its residents, and in accord with the public purposes and provisions of applicable State and local laws and requirements; and

WHEREAS, the Agency desires to use funds from the 1994

District 8 CDBG funds and matching funds from the Centre City

East District of the Centre City Redevelopment Project Fiscal

Year 1995-96 Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it finds and determines that, based upon the information set forth in Attachment No. 1 (attached hereto and incorporated herein by this reference) the use of funds from the 1994 District 8 CDBG funds as authorized by this reference will be of benefit to the Project area.

BE IT FURTHER RESOLVED, that staff from the Centre City
Development Corporation, together with the Centre City East
Association, work with staff from the affected City Council

District offices and People for Trees to ensure an equitable distribution of tree locations within the entire Centre City East Subarea of the Project.
