

Navistar International Transportation Corp., et al. v. City of San Diego, et al., U.S. District Court Case No. 92-1612GT (BTM), over and above the sum previously authorized on January 17, 1995, January 31, 1995 and May 10, 1995; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay for attorney's fees and costs to the law firm of Higgs, Fletcher and Mack as counsel representing The City of San Diego in the case, Solar Turbines, Inc. v. Navistar International Transportation Corp., et al. v. City of San Diego., et al., up to and including the amount of \$100,000 in addition to the previous authorization of \$395,000;

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to set aside and

expend an amount not to exceed \$100,000 for the purpose of paying legal fees and costs incurred by counsel representing The City of San Diego.
