BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to revise the phase funding schedule for the construction contract with Nielsen-Dillingham Builders, Joint Venture, in connection with the Fiesta Island/Northern Sludge Processing Facility - Yard Piping and Power Distribution, scheduling date changes due to project delays and reduction of contingencies.

BE IT FURTHER RESOLVED, that the phase-funded expenditure of an amount not to exceed \$21,437,686 from Metropolitan Wastewater Department Sewer Fund 41509, CIP No. 42-911.4, Northern Sludge Processing Facility, Phase II, is hereby authorized, solely and exclusively to fund this construction contract, contingencies, and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon advice of the administering department.

BE IT FURTHER RESOLVED, that the City Manager is authorized to revise contract funding phases with Nielsen-Dillingham based on the actual low bid submitted in the following manner, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for expenditure

under this contract are, or will be, on deposit in the City Treasury:
