A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REALLOCATING AND TRANSFERRING FISCAL YEAR 1996 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That one hundred one thousand dollars (\$101,000) in Fiscal Year 1996 Community Development Block Grant ("CDBG") funds, Fund 18531, previously allocated to Section 108 Loan Repayment for the Mercado Commercial Project, Department 4094, Organization 9402, be reallocated to the Mercado Apartments Project, Department 4086, Organization 8603.
- 2. That the Council approves the transfer and disbursement of the above-referenced one hundred one thousand dollars (\$101,000) to the Redevelopment Agency of The City of San Diego (the "Agency") for use in the Mercado Apartments Project, Fund 98902, in the Barrio Logan Redevelopment Project.
- 3. That the Auditor and Comptroller is directed to record the above disbursement to the Agency as an interest bearing loan, and such loan shall accrue interest as calculated by the City Auditor and Comptroller, to be repaid from tax increment or other revenues.
- 4. That in the event the Agency issues bonds, notes, refunding bonds or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any

indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocation received by the Agency pursuant to California Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
