A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A \$336,000 LOAN REPAYMENT FROM THE MOUNT HOPE REDEVELOPMENT PROJECT AREA, AND APPROPRIATING \$336,000 TO BE LOANED BACK TO THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO; ACCEPTING A \$320,000 LOAN REPAYMENT FROM THE GATEWAY CENTER WEST REDEVELOPMENT PROJECT AREA, AND APPROPRIATING \$320,000 TO BE LOANED BACK TO THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.

WHEREAS, the Council of The City of San Diego (the "City") has previously given general approval to the financing plans for the Central Imperial and Gateway Center West Redevelopment Areas and the Dells/Imperial Study Area of the Redevelopment Agency of The City of San Diego (the "Agency"); and

WHEREAS, the Agency has previously borrowed six hundred fifty-six thousand dollars (\$656,000) in Community Development Block Grant ("CDBG") monies from the City; and

WHEREAS, these monies are necessary to carry out the implementation of these Redevelopment and Study Areas; NOW, THEREFORE.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That it hereby accepts as a loan repayment from the Mount Hope Redevelopment Project, three hundred thirty-six thousand dollars (\$336,000) from CDBG funds that had previously been loaned to the Agency.

2. That it appropriate three hundred thirty-six thousand dollars (\$336,000) to be loaned back to the Agency to be used in the Fiscal Year 1995-96 Project Budget for project implementation costs in the Central Imperial Redevelopment Area as follows:

- 3. That it hereby accepts as a loan repayment from the Gateway Center West Redevelopment Project, three hundred twenty thousand dollars (\$320,000) in CDBG monies that had previously been loaned to the Agency.
- 4. That it appropriate three hundred twenty thousand dollars (\$320,000) to be loaned back to the Agency to be used in the Fiscal Year 1995-96 Project Budget for project implementation costs in the Gateway Center West Redevelopment Area as follows:

6. That the City Auditor and Comptroller is hereby directed to record the above loan as an interest bearing loan to the Agency, to be repaid as soon as practicable from tax increment or other appropriate revenues.
