## RESOLUTION NUMBER R-286145 ADOPTED ON JULY 24, 1995

WHEREAS, the San Diego Police Department, through The City of San Diego ("City"), desires to undertake a certain project designated Southeast Asian Community Crime Resistance Grant, to be funded in part from funds made available through the Community Crime Resistance Program administered by the California Office of Criminal Justice Planning ("OCJP"); and

WHEREAS, this program shall be used for the purposes of augmenting and enhancing community policing, community empowerment, and crime prevention in Southeast Asian communities throughout the City; NOW, THEREFORE,

that the City Manager be and he is hereby authorized and empowered, for and on behalf of said City, to apply for, accept and administer funds for a Community Crime Resistance Grant from the California Office of Criminal Justice Planning, for a program to enhance community empowerment and crime prevention in Southeast Asian populations throughout the City, as described in the approved grant application, a copy of which is on file in the office of the City Clerk as Document No. RR-286145, and that such authorization shall include all aspects of grant acceptance, operation, expenditures, and certification that the City will comply with all applicable statutory or regulatory requirements related to said program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute any amendments, extensions, renewals, or future funding for this program for a period of up to five years, provided funding is made available by the California Office of Criminal Justice Planning.

BE IT FURTHER RESOLVED, that the City agrees to provide all matching funds required for said project, including any amendments thereof, under the Program and funding terms and conditions of OCJP, and that the cash match will be appropriated as required.

BE IT FURTHER RESOLVED, that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of The City of San Diego.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant expenditures controlled by this City Council.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to identify the Hmong and Vietnamese populations

as communities to focus on in the Community Crime Resistance/ Southeast Asian Grant.
