ADOPTED ON JULY 25, 1995

RESOLUTION CONSIDERING THE PROTESTS,  
APPROVING MODIFIED MAP, CONFIRMING THE  
ASSESSMENTS, AND ORDERING THE PROPOSED  
MAINTENANCE, IN THE MATTER OF THE SCRIPPS-  
MIRAMAR RANCH LANDSCAPE MAINTENANCE DISTRICT.

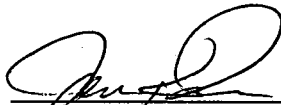
