BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with Daniel Boyle Engineering, Inc., for as needed pipeline value engineering services, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 286232, as well as any reasonably necessary modifications or amendments thereto which do not increase this agreement's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000, consisting of \$100,000 from Sewer Revenue Fund 41506, CIP No. 46-174.0, Annual Allocation, As-Need Consultant Services/Sewer, and \$100,000 from Water Revenue Fund 41500, CIP No. 73-312.0, Annual Allocation, As-Needed Consultant Services/Water, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
