## RESOLUTION NUMBER R- 286275 ADOPTED ON AUG 15 1995

WHEREAS, under Section II, 36(b) and Attachment A of Ordinance No. O-18193, adopted on July 25, 1995, the City's Transient Occupancy Tax Fund allocation for Arts and Cultural Programs, the San Diego Symphony Association ("Symphony") was allocated \$418,282 for Fiscal Year 1995-96; and

WHEREAS, pursuant to the original Allocations Programs for Organizational Support Agreement between City and Symphony for Fiscal Year 1995-96, the Symphony received \$200,000 of the allocated money for Fiscal Year 1995-96; and

WHEREAS, the Symphony has asked for the balance of the allocation to be paid to it immediately with a revised set of program objectives; and

WHEREAS, the City agrees that the goal of the Allocations

Program will be met by these alternative program objectives; and

WHEREAS, the proposed alternative program to be accomplished by Symphony continues to contribute to a balance of community cultural, recreational, and promotional programs designed to enhance the well-being of the community; and

WHEREAS, the program to be accomplished by Symphony is of such nature that the interests of City continue to be better served by an agreement with Symphony than by the performance of such a program by City; and

WHEREAS, the City Council is desirous of granting Symphony's request; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be authorized to execute an amendment to the existing Allocations Program for Organizational Support Agreement with the San Diego Symphony Association in accordance with the following:

- 1. The balance of \$218,282 allocated to Symphony under Ordinance No. O-18193 be payable immediately upon execution of the First Amendment to Agreement between City and Symphony.
- 2. The First Amendment to Agreement to contain waivers of Council Policy 100-03, Sections 4(i), pertaining to the 13th payment, B-5 and D.
- 3. The First Amendment to Agreement to contain an amended Scope of Services (Program Objectives), that is, an amended Exhibit A.
- 4. In accordance with Section II, 36(b) of Ordinance No. O-18193, the Symphony shall repay City the equivalent of one-thirteenth of \$418,282 if actual Transient Occupancy Tax revenues do not meet budget projections.

BE IT FURTHER RESOLVED, that the City Manager be authorized to execute the First Amendment to the Agreement between City and Symphony with the understanding that the San Diego Symphony Association be required to file a restructuring plan, which includes a revised business, marketing, and fundraising plan, as part of the Fiscal Year 1997 funding application submitted to the City of San Diego Commission for Arts and Culture Allocations
