BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$457,637 from CIP 58-004.0, Annual Allocation Miscellaneous Requirements - City Streets TransNet Fund 30300; an amount not to exceed \$702,363 from CIP 52-619.0, Otay Mesa Road Widening - Temporary State Route 905, Transnet Fund 30302; and an amount not to exceed \$365,000 from CIP 52-433.0, Fairmount Avenue from Montezuma Road to I-8, TransNet Bond Proceeds Fund 30302 to CIP 52-513.0, Crosby Street Widening - Harbor Drive to I-5, Prop A Fund 30300.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$700,000 from CIP 58-004.0, Annual Allocation

Miscellaneous Requirements - City Streets, TransP Fund, to CIP 52-619.0, Otay Mesa Road Widening - Temporary State Route 905, as those funds may be received from TransNet services and become available for such transfer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,525,000, (456,637 from CIP 52-513.0, Crosby Street Widening - Harbor Drive to I-5, Prop A Fund 30300; and \$1,067,363 from TransNet Bond Fund 30302), is hereby authorized, solely and exclusively for settlement of condemnation proceedings entitled "City of San Diego vs. Henry P. and Charlotte Piepenkotter" (SDSC No. 676428-1).
