BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute all aspects of program operation including any amendments, extensions, renewals, or future funding for this program for a period of up to five years, provided funding is made available by the United States Department of Justice and/or the National Institute of Justice, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program;

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
