BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$219,470, consisting of \$109,470 from Water Fund 41500, CIP No. 73-290.0, San Pasqual Water Reclamation Facility, and \$110,000 from Sewer Revenue Fund 41506, CIP No. 46-151.0, San Pasqual Water Reclamation Facility, is hereby authorized, solely and exclusively to provide funds for this Amendment No. 3.
