BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized transfer of \$203,553.00 from CIP No. 22-024.2, SOUTH SHORES DEVELOPMENT - PHASE II, Capital Outlay - Other Fund No. 302453, \$350,000.00 from Fiesta Island Sludge Mitigation Fund No. 10507, and \$1,800,000.00 from CIP No. 21-834.0, BALBOA PARK/MISSION BAY REQUIREMENTS, San Diego Facilities and Equipment Construction Fund No. 91101 (following issuance of Certificates of Participation Bonds) to CIP No. 22-024.3, SOUTH SHORES DEVELOPMENT - PHASE III.
