BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the College Community Redevelopment Project Area Committee consisting of persons named on the list of Project Area Committee members receiving the highest number of votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

- 2. That the Council hereby concurs that the election results are valid and binding in accordance with the procedures so adopted by Resolution No. R-280718.
- 3. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area for a period of three (3) years after adoption of the Redevelopment Plan.
