A RESOLUTION ESTABLISHING AN UNDERGROUND UTILITY DISTRICT TO BE KNOWN AND DENOMINATED AS THE "G" STREET (7TH AVENUE TO HIGHWAY 94) UNDERGROUND UTILITY DISTRICT.

WHEREAS, by Resolution No. R-286466, a public hearing was called for on Normally 28,995 at the hour of Nov 4.M in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety or general welfare requires the removal of poles, overhead wires and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within that certain area of the City of San Diego more particularly described as follows:

Lots G-K of BLOCK 71, Lots B-L of BLOCK 72, Lots B-L of BLOCK 73, Lots B-K of BLOCK 74, Lots B-K of BLOCK 75, Lots B-K of BLOCK 76, LOTS A-L of BLOCK 77, Lots D-L of BLOCK 78, Lot A of BLOCK 80, Lots A-D and I-L of BLOCK 81, Lots A-D and I-L of BLOCK 82, Lots A-D and I-L of BLOCK 83, and Lots A-D and I-L of BLOCK 84, Lots A-D and I-L of BLOCK 85, Lots I-L of BLOCK 86, Lots A-L of BLOCK 176 of HORTON'S ADD LOCKLING DB 13 PG 522; Lots 7-9 of BLOCK 12, Lots 4-12 of BLOCK 13, Lots 1-9 of BLOCK 14, Lots 6-10 of BLOCK 15, Portion of Lots 1-5 of BLOCK 16, Lots 1 and 8 of BLOCK 17, Lots 2-3 of BLOCK 18, Lots 6-8 of BLOCK 19 of CULVERWELL'S ADD TO SAN DIEGO MAP 143.

Said district shall also include the following described public rights-of-way:

"G" STREET between a line parallel to and 150 feet west of the westerly line of 7th Avenue and the westerly boundary of HWY 94; 7TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and the southerly line of "F" Street; 8TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and the southerly line of "F" Street; 9TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and the southerly line of "F" Street; 10TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and a line parallel to and 250 feet north of the northerly line of "G" Street; 11TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and a line parallel to and 250 feet north of the northerly line of "G" Street; 12TH AVENUE between a line parallel to and 200 feet south of the southerly line of "G" Street and a line parallel to and 250 feet north of the northerly line of "G" Street; 13TH STREET between a line parallel to and 50 feet south of the southerly line of "G" Street and a line parallel to and 150 feet north of the northerly line of "G" Street; 14TH STREET between a line parallel to and 50 feet south of the southerly line of "G" Street and a line parallel to and 250 feet north of the northerly line of "G" Street; 15TH STREET between a line parallel to and 65 feet south of the southerly line of "G" Street and a line parallel to and 150 feet north of the northerly line of "G" Street; 16TH STREET between a line parallel to and 50 feet south of the southerly line of "G" Street and the southerly line of "F" Street; 17TH STREET between a line parallel to an 150 feet south of the southerly line of "G" Street and a line parallel to and 150 feet north of the northerly line of "G" Street.

all as more particularly shown on Drawing No. 27353-D entitled "'G' STREET (7TH AVENUE TO HIGHWAY 94) UNDERGROUND UTILITY DISTRICT," copies of which are on file in the office of the City Clerk as Document No. RR- 286466 and attached hereto and incorporated herein as Exhibit A; and

WHEREAS, notice of such hearing has been given by the City Clerk to all affected property owners as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and the utilities concerned in the manner and for the time required by law; and

WHEREAS, such hearing has been duly and regularly held and all persons interested have been given an opportunity to be heard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The City Council does hereby find and determine that the public health, safety and general welfare require the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service within the area set forth above and that pursuant to Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, the above-described area is hereby declared to be an underground utility district in the City of San Diego, and the

maps and document referred to above are hereby incorporated as a part of this resolution.

- 2. The City Council shall by subsequent resolution fix the date upon which the property in the district must be ready to receive underground service, and shall by subsequent resolution order the removal of all poles, overhead wires and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service.
- The City Clerk be and he is hereby instructed to notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code, and all affected utility companies of the adoption of this resolution within fifteen (15) days after the date of such adoption. The City Clerk shall further notify said affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code of the necessity that if they desire to continue to receive electric, communication, community antenna television or similar or associated service they shall provide at their own expense all necessary facility changes on their premises so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California (as of the date of adoption of this resolution) and subject to all other applicable requirements of State law and City

ordinances. The Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.
