A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER AND CITY AUDITOR TO UTILIZE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS AS A FLOAT LOAN TO THE ENTERPRISE COMMUNITY PROGRAMS SO THAT THEY CAN COMMENCE OPERATIONS IN A TIMELY MANNER.

WHEREAS, the City of San Diego received designation as an Enterprise Community in December of 1994; and

WHEREAS, such designation provides a one time allocation of \$2.95 million for community and economic revitalization purposes in the designated area; and

WHEREAS, the City has designated services and selected programs to be funded in its application in conformance with its two-year plan; and

WHEREAS, the City has by Resolution No. 282299 approved the City Manager's recommendation for a short term or "float loan" program to provide transitional funding of CDBG eligible project; and

WHEREAS, there is a need for operating capital advances so that the Council related community based agencies can begin providing services in the Enterprise Community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized to amend the City's FY 96 CDBG budget to appropriate \$302,370 as a float loan to the Enterprise Community programs as listed below,

such funds to be repaid to the CDBG program from the Enterprise Community grant no later than December 1998.

- 2. That the City Manager be and he is hereby authorized to amend the City FY 96 Consolidated Plan to reflect the addition of the Enterprise Community programs.
- 3. That the Manager be and he is hereby authorized to utilize repayments from the Enterprise Community grant to fund the originally designate CDBG programs as listed below:
