AN ORDINANCE AMENDING ORDINANCE NO. 0-18328 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE AMENDING THE ADOPTED ANNUAL BUDGET FOR THE FISCAL YEAR 1996-97 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-18328, AS AMENDED AND ADOPTED THEREIN, BY ADDING CIP 39-223.0, MESA TOP ACQUISITION; AND BY AMENDING THE GENERAL FUND BUDGET TO APPROPRIATE \$142,139.40 OF UNANTICIPATED COUNTY REFUND OF ELECTIONS SERVICES BILLINGS TO BE TRANSFERRED TO MESA TOP MITIGATION FUND 10594, FOR OPEN SPACE LITIGATION PURPOSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-18328 (New Series), as amended, entitled "AN ORDINANCE AMENDING THE ADOPTED ANNUAL BUDGET FOR THE FISCAL YEAR 1996-97 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-28328, as amended and adopted therein by adding CIP 39-223.0, Mesa Top Acquisition.

Section 2. That Ordinance No. O-28328 (New Series), as amended, entitled "AN ORDINANCE AMENDING THE ADOPTED ANNUAL BUDGET FOR THE FISCAL YEAR 1996-97 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-28328, as amended and adopted therein by amending the General Fund

Budget to appropriate \$142,139.40 of unanticipated county refund of election services billings to be transferred to Mesa Top Mitigation Fund 10594, for open space litigation purposes

Section 3. That the City Auditor and Comptroller is hereby authorized and directed to establish the "Mesa Top Mitigation Fund," number 10594, for the purpose of expenditures related to the settlement in the case of <u>Torrey Pines Investment Group</u>, et al., vs. City of San Diego.

Section 4. That the appropriation and expenditure of not to exceed \$2 million from CIP 39-223.0, Mesa Top Acquisition, Mesa Top Mitigation Fund 10594, for partial settlement in the case of <u>Torrey Pines Investment Group</u>, et al. vs. City of San Diego, is hereby authorized.

Section 5. That the expenditure for required environmental mitigation of \$1,210,477 as follows: \$638,580 from CIP 523620, Nobel Drive Extension and I-805 Interchange, Fund 79001; \$45,000 from CIP 525570, North Torrey Pines Road Bridge over AT&SF Railroad, Fund 30300; \$45,000 from CIP 530500, North Torrey Pines Road Bridge over Los Penasquitos Creek, Fund 30300; \$481,897 from CIP 524630, State Route 56-Carmel Valley to Rancho Penasquitos, Fund 30302, to be deposited in Mesa Top Mitigation Fund 10594, is hereby authorized and approved.

Section 6. That the appropriation and expenditure of not to exceed \$582,383.60 from Open Space Bond Fund 79104, to reimburse open space acquisition expenditures incurred by Mesa Top Mitigation Fund 10594, is hereby authorized and approved.

Section 7. That the appropriation and transfer of \$65,000 from Black Mountain Ranch

Development Agreement Fund, 392190, to be deposited in the Mesa Top Mitigation Fund 10594.

Section 8. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
