AN ORDINANCE AMENDING ORDINANCE NO. O-18328 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1996-97 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-18328 TO EXEMPT A POSITION OF COUNCIL REPRESENTATIVE IN COUNCIL DISTRICT 5 FROM THE CLASSIFIED SERVICE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 5, 1996, as indicated in Exhibit A attached hereto, a position of Council Representative in Council District 5 be and is hereby exempted from the classified service and declared to be in the unclassified service of The City of San Diego.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

Classified Service

On December 5, 1996, the Civil Service Commission reviewed the request of Councilmember Barbara Warden to exempt a District 5 Council Representative position from the Classified Service. This position will provide the District and the Deputy Mayor's Office with staff support for research and analysis of community and policy issues, and assist with constituent affairs to enable the Councilmember to carry out the added responsibilities of Deputy Mayor.

Charter Section 117 states that the Unclassified Service shall include "managerial employees having significant responsibilities for formulating and administering department policies and programs. Each such position shall be exempt from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council."

Upon review of the duties and responsibilities of this position, the Commission finds that it meets the intent of Charter Section 117. If additional information would be of assistance in your consideration of this matter, staff is available to respond with details as necessary.

Attached is a request from Councilmember Barbara Warden of District 5 to exempt one additional Council Representative position from the Classified Service.

Charter Section 117 states that the Unclassified Service shall include "managerial employees having significant responsibilities for formulating and administering department policies and programs. Each such position shall be exempt from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council."

To carry out the additional responsibilities of Deputy Mayor, Councilmember Warden requires an additional position to work with community constituents and represent the Councilmember on a wide variety of district issues. The position will also coordinate with the City and other agencies to develop and implement goals, policies, objectives, programs, and inter-agency cooperation at a policy setting level on these issues.

Staff has determined that the duties and responsibilities of the position are consistent with the intent of the Council Representative classification, and the duties are comparable to those performed by other properly classified Council Representatives in District 5 and throughout the City. All of those positions have been exempted from the Classified Service as well.
