

RESOLUTION NO. 197939

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an Option-Sales Agreement with Logicon, Inc., a California corporation, covering the option to purchase Lots 3 and 4 of Torrey Pines Science Park Unit No. 1, under the terms and conditions set forth in the form of Option-Sales Agreement, on file in the office of the City Clerk as Document No. 729420.

2. That the Mayor and the City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a grant deed conveying to LOGICON, INC., a California corporation, Lot 3 of Torrey Pines Science Park Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6229, filed November 21, 1968, in the office of the San Diego County Recorder, all as more particularly set forth in the form of deed on file in the office of the City Clerk as Document No. 729421; said grant deed being pursuant to the Option-Sales Agreement entered into between the parties of said deed, dated September 9, 1969, on file in the office of the City Clerk as Document No.

729420.

3. That the Mayor and the City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a grant deed conveying to LOGICON, INC., a California corporation, Lot 4 of Torrey Pines Science Park Unit No. 1,

in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6229, filed November 21, 1968, in the office of the San Diego County Recorder, all as more particularly set forth in the form of deed on file in the office of the City Clerk as Document No. 729422; said grant deed being pursuant to the Option-Sales Agreement entered into between the parties of said deed, dated September 9, 1969, on file in the office of the City Clerk as Document No. 729420.

4. That the City Clerk be, and he is hereby authorized and directed to deliver said agreement, deeds and certified copies of this resolution to the Property Director for further handling.
