WHEREAS, The City of San Diego is the owner of a sewer easement in Lots 7, 8 and 12-19 of Block 6, La Jolla Strand, Map 1216; and

WHEREAS, the Development Services Department has requested that the City quitclaim to LA JOLLA PALMS LIMITED PARTNERSHIP and MANDARIN PARTNERS, a California limited partnership, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to his property; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City quidelines for implementation of said Act, as amended; and

WHEREAS, the City desires to negotiate the sale of said easement to LA JOLLA PALMS LIMITED PARTNERSHIP and MANDARIN PARTNERS, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property, as determined by City staff, is the cost of processing the documents; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the sewer easement in Lots 7, 8 and 12-19, Block 6, La Jolla Strand, Map 1216, as described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 286881 be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the cost of processing the documents to LA JOLLA PALMS LIMITED PARTNERSHIP and MANDARIN PARTNERS.
- 2. That the City Manager or his designee is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- 286881, quitclaiming to LA JOLLA PALMS LIMITED PARTNERSHIP and MANDARIN PARTNERS that certain easement, as more particularly described in the quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed and a certified copy of this

resolution, attested by him under seal, to the Development Services Department for further handling.
