## RESOLUTION NUMBER R- 286910 ADOPTED ON FEB 12 1996

WHEREAS, the Office of Community Oriented Policing Services and the Office of Violence Against Women Act of the United States Department of Justice, under the Crime Act of 1994, have solicited proposals for grant programs which implement a Community Policing approach to domestic violence; and

WHEREAS, an ad hoc committee was formed to identify the most useful, comprehensive and critical plan for use of grant funds; and

WHEREAS, said committee was comprised of representation from the San Diego Domestic Violence Council (which is representative of virtually every agency in San Diego County providing services to domestic violence victims, their families, and perpetrators); the Center for Women's Studies and Services; the YWCA of San Diego County Domestic Violence Services Division; and the San Diego Police Department Domestic Violence Section; and

WHEREAS, said committee unanimously determined that a tollfree clearinghouse information network is the most critical priority which meets grant program requirements; and

WHEREAS, said committee also unanimously determined that the YWCA of San Diego County Domestic Violence Services Division is the most appropriate agency to house and operate the clearing house information network program; and

WHEREAS, there is no requirement for matching funds, but City of San Diego in-kind matching resources consisting of fiscal, administrative and operational support have been identified in order to increase the competitiveness of the proposal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City of San Diego, to apply for, accept and expend the grant from the United States Department of Justice, as described in the proposal, a copy of which is on file in the Office of the City Clerk as Document NO. RR-

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that should said proposal be selected for funding by the United States Department of Justice, the authority of the City Manager shall explicitly include the authority to enter into a contract agreement with the YWCA of San Diego County Domestic Violence Services to operate and house the program under the program and budget terms and conditions contained in the approved grant proposal.

BE IT FURTHER RESOLVED, that the Council hereby authorizes the City Manager to execute all aspects of program operation including any amendments, extensions, renewals, or future funding for this program for a period of up to five years, provided funding is made available by the United States Department of Justice, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program.

BE IT FURTHER RESOLVED, that any resources received hereunder shall not be used to supplant expenditures controlled by this body.
