APPROVING MAP OF SR252 - PHASE 1

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Lonie K. Cyr, Licensed Land Surveyor, entitled "SR252 - PHASE 1, being a subdivision of Lot 9, 33 through 36 inclusive, 38 through 41 inclusive, 45 through 48 inclusive and a portion of Lots 3 through 8 inclusive, 32, 37, 42, and 44 of Ocean Vista Gardens, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 2208, filed in the office of the County Recorder of San Diego County, August 18, 1936 and portions of Lots 45 through 48 inclusive, of Block "F" of Ocean Vista Addition, according to Map thereof No. 1793, filed in the office of the County Recorder of San Diego County, May 22, 1924, together with Alpha Street, 41st Street and portions of Alpha Street and Beta Street as dedicated to public use, together with Beta Street, unnamed alleys in Block "F" and in portion of the southerly half of Block "C," both of Ocean Vista Addition, according to Map No. 1793 and a portion of Alpha Street, all as closed and vacated to public use. Easements dedicated to the public use per Map No. 2208, drainage easement granted to the City of San Diego per document recorded September 26, 1995 as File No. 1995-0429731, official records and general utility easements and sewer easement reserved per document recorded


November 7, 1995 as File No. 1995-0507887, official records, were not shown on map, they have been abandoned pursuant to Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Beta Street, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated; as granted and shown on this map is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
