A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, OPERATION AND MAINTENANCE OF THE FIESTA ISLAND REPLACEMENT PROJECT --PHASE II, A GENERAL UTILITY EASEMENT PIPELINE, AND ALL INCIDENTS AND APPURTENANCES THERETO TO PROVIDE A PIPELINE THAT WILL CONTAIN UTILITY SERVICE LINES AND THAT WILL CARRY DIGESTED SLUDGE FROM THE POINT LOMA WASTEWATER TREATMENT PLANT TO THE PROPOSED SLUDGE PROCESSING FACILITY AT NAS MIRAMAR; THAT SAID PUBLIC PIPELINE WILL NECESSARILY REQUIRE THE ACQUISITION OF PERMANENT GENERAL UTILITY EASEMENTS AND TEMPORARY CONSTRUCTION EASEMENTS OVER, UNDER, UPON, ALONG AND ACROSS PORTIONS OF REAL PROPERTY LOCATED IN THE NORTHERN PORTION OF THE KEARNY MESA COMMUNITY OF THE CITY OF SAN DIEGO, AT THE SOUTHEAST CORNER OF I-805 AND STATE ROUTE 52, AS MORE PARTICULARLY DESCRIBED HEREINAFTER, ALL IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITIONS; THAT THE PROPOSED PROJECT IS PLANNED IN A MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY; AND DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY, PURSUANT TO GOVERNMENT CODE SECTION 7267.2, AT THE APPRAISED FAIR MARKET VALUE HAS BEEN MADE TO THE OWNERS OF RECORD OF THE PROPERTY; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID EASEMENTS UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID EASEMENTS AND ACQUIRING IMMEDIATE POSSESSION THEREOF.

WHEREAS, the Council of the City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure, and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,


Section 1. That the public interest, convenience and necessity of the City of San Diego, and the inhabitants thereof, require the construction, operation and maintenance of the Fiesta Island Replacement Project—Phase II, a general utility easement pipeline, and all incidents and appurtenances thereto, to provide a public pipeline that will contain utility service lines and that will carry digested sludge from the Point Loma Wastewater Treatment Plant to the proposed sludge processing facility at NAS Miramar over portions of property located in the northern portion of the Kearny Mesa community of the City of San Diego, at the southeast corner of I-805 and State Route 52, as more particularly described hereinafter, all in the City of San Diego, County of San Diego, State of California.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of permanent general utility easements, and temporary construction easements in said property for the construction, operation and maintenance of a public pipeline project and all incidents and appurtenances thereto, together with the right of ingress and egress over, under, upon, along and across portions of said real property lying within the City of San Diego, County of San Diego, State of California.
