WHEREAS, Susan Lew's firm, S. Lew & Associates, Inc. is the largest Asian-owned real estate company in San Diego, assisting San Diego's Asian community and international clients through the sales process; and

WHEREAS, Susan has been an active civic leader in San Diego since 1980, promoting human services, cultural, educational and international business opportunities; and

WHEREAS, Susan has distinguished herself further through her leadership to Union of Pan Asian Communities (UPAC) and through her chairing the San Diego Chinese Center; and

WHEREAS, Susan's service on the Board of Directors for the Bank of Commerce, the San Diego County International Commission and the State of California's Advisory Commission for California-Canada Trade Relations has contributed greatly to San Diego's reputation as an emerging center of international trade; and

WHEREAS, Susan's membership in the San Diego-Yantai Sister
City Society and numerous other charitable and civic
organizations, including Mayor Golding's Strategic Trade Alliance

of the Region and the Tideland Advisory Council have further enhanced Susan Lew's credentials as a recognized civic leader; and
