


RESOLUTION NUMBER R- 287033

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with the Black Contractors Association, Inc., for the design and construction of a Teaching Studio for the Applied and Practical Industrial Arts and other specific commercial uses, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287033.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$340,000 from CDBG Fund 18529, Dept. 4042, Org. 4209, JO 112359 and an amount not to exceed \$300,000 from CDBG Fund 18530, Dept. 4062, Org. 6208, JO 112359, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


CERTIFICATION OF UNENCUMBERED BALANCE
