
ADOPTED ON MAR 18 1996

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with Chicano Federation of San Diego, for the design and construction renovation of their buildings at 2130 Market and 610 22nd Street, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287034.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$225,000 from CDBG Fund 18530, Dept. 4062, Org. 6202, JO 112003 and an amount not to exceed \$100,000 from CDBG Fund 18531, Dept. 4082, Org. 8211, JO 112003, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
