BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Linda Vista Health Care Center, a non-profit California Corporation ("Agency") that would make available to the Agency \$105,634.89 in CDBG Funds, for the Master Plan and the design of the Agency's additional building with connection to the original building, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287036.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$125,000 from CDBG Fund 18529, Linda Vista Health Care Center, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


CERTIFICATION OF UNENCUMBERED BALANCE
