BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$2,000,000 from Sewer Fund 41509, CIP 46-170.0, Point Loma Digester Facility Upgrade and Expansion, and an amount not to exceed \$747,320 from Sewer Fund 41509, CIP 40-921.0, FIRP Phase II Digested Sludge and Centrate Pipeline, both to Sewer Fund 41509, CIP 42-911.3, North City Raw Sludge and Water Pipelines.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,747,320 from Fund 41509, CIP 42-911.3, North City Raw Sludge and Water Pipelines, is hereby authorized, solely and exclusively as follows: \$2,616,495 for construction, and \$130,825 for contingency in connection with the above project.
