A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, OPERATION AND MAINTENANCE OF THE MIRAMAR RECLAIMED WATER STORAGE TANK PROJECT, A PUBLIC RECLAIMED WATER STORAGE TANK, AND ALL INCIDENTS AND APPURTENANCES THERETO TO PROVIDE FOR STORAGE OF HIGHLY TREATED WASTE WATER FROM THE NORTH CITY RECLAMATION PLANT, AND TO ENABLE THE CITY TO UTILIZE HIGHLY TREATED WASTE WATER FOR IRRIGATION PURPOSES, AS A REQUIRED COMPONENT OF THE GREATER SAN DIEGO RECLAIMED WATER DISTRIBUTION SYSTEM IN THE SCRIPPS-MIRAMAR RANCH AREA IN THE CITY OF SAN DIEGO; THAT SAID PUBLIC RECLAIMED WATER STORAGE TANK WILL NECESSARILY REQUIRE THE ACQUISITION OF FEE SIMPLE ABSOLUTE TO LOT 5 AND A TEMPORARY CONSTRUCTION EASEMENT OVER, ALONG, ACROSS, AND THROUGH LOT 6 IN THE SCRIPPS RANCH BUSINESS PARK PHASE III, ALL IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITIONS; THAT THE PROPOSED PROJECT IS PLANNED IN A MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY; AND DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY, PURSUANT TO GOVERNMENT CODE SECTION 7267.2, AT THE APPRAISED FAIR MARKET VALUE HAS BEEN MADE TO THE OWNERS OF RECORD OF THE PROPERTY; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID FEE SIMPLE ABSOLUTE AND TEMPORARY CONSTRUCTION EASEMENT UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY AND ACQUIRING IMMEDIATE POSSESSION THEREOF.

WHEREAS, the Council of the City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure, and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,

Section 1. That the public interest, convenience and necessity of the City of San Diego, and the inhabitants thereof, require the construction, operation and maintenance of the Miramar Reclaimed Water Storage Tank Project, a public reclaimed water storage tank and all incidents and appurtenances thereto, to provide for storage of highly treated waste water from the North City Reclamation Plant, and to enable the City to utilize highly treated waste water for irrigation purposes, as a required component of the greater San Diego Reclaimed Water Distribution System, in portions of property located in the Scripps Ranch Business Park Phase III in the Scripps-Miramar Ranch area, all in the City of San Diego, County of San Diego, State of California, as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of fee simple absolute to Lot 5 and a temporary construction easement over, along, across, and through Lot 6 for the construction, operation and maintenance of a public reclaimed water storage tank and all incidents and appurtenances thereto, on property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That Section 220, Charter of the City of San Diego; Sections 1240.010, 1240.110, 1240.120 and 1255.410, Code

of Civil Procedure; and Sections 37350.5, 38730, 38731, 38900, and 40404, Government Code, permit the acquisitions referenced herein.

Section 4. That the legal description of the parcels of real property and the interests sought to be condemned are as follows:

Lots 5 and 6 of Scripps Ranch Business Park

Phase III, in the City of San Diego, County

of San Diego, State of California, According

to Map Thereof No. 12130, filed in the office

of the County Recorder of San Diego County,

July 27, 1988.

Section 5. That the taking and acquiring by said City of fee simple absolute to Lot 5 and a temporary construction easement over, along, across, and through Lot 6, hereinabove described is deemed necessary for the construction, operation and maintenance of a public reclaimed water storage tank and all incidents and appurtenances thereto to provide for storage of highly treated waste water from the North City Reclamation Plant, and to enable the City to utilize highly treated waste water for irrigation purposes, as a required component of the greater San Diego Reclaimed Water Distribution System in the Scripps-Miramar Ranch area in the City of San Diego, for municipal purposes; and that such uses are public uses authorized by law (Section 220, Charter of the City of San Diego; Sections 1240.010, 1240.110, 1240.120, and 1255.410, Code of Civil Procedure; and Sections 37350.5, 38730, 38731, 38900, and 40404, Government Code); that for such public use, it is necessary that the City of San Diego

condemn and acquire said fee simple absolute and temporary construction easement; that said real property is to be used for the construction, operation and maintenance of a public reclaimed water storage tank and all incidents and appurtenances thereto, for the Miramar Reclaimed Water Storage Tank Project, which is planned and located in a manner most compatible with the greatest public good and the least private injury.

Section 6. That an offer to acquire the property, pursuant to Government Code Section 7267.2, at the appraised fair market value has been made to the owners of record of the property.

Section 7. That the City Attorney of the City of San Diego be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of the City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the property as above described and obtaining immediate possession of said parcels for the use of said City.
